Re: Round 59 Call for Applications for Forestry Futures Silviculture Projects

I am pleased to invite you to participate in the 59th call for applications for silviculture funding from the Forestry Futures Trust (FFT). We encourage you to submit applications for eligible work by the deadline of Friday, October 18, 2024.

Applications should include a wood supply analysis, emphasize the cost effectiveness of described treatments, and demonstrate that treatment areas have been surveyed for accuracy. Funding preference will be given to projects which are on productive sites, have good access, and are an economical distance from the mill.

Silviculture project application and budget forms can be found on our website (<u>www.forestryfutures.com</u>) under 'Forms and Reports/Downloadable Forms'. We ask that you download and submit *only* the most current versions of these forms.

The FFTC Silviculture Project Application Guide (revised September 2024) is provided with this letter and also available for download from our website. We recommend that you review it for an understanding of the four eligibility categories: Intensive Stand Management, Stand Rehabilitation of Natural Disturbances, Pest Control, and Insolvency. Appendix 1 provides a list of project conditions currently eligible for funding in each category and Appendix 2 provides clarification of conditions under which tending treatments may be considered as eligible expenses. The Guide also outlines information that the Committee requires and uses to evaluate projects and prioritize funding allocation.
